14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ A CASH DISTRIBUTION WAS PAID TO HOLDERS OF GASLOG PARTNERS LP COMMON UNITS ON 08/10/2018. THE 08/10/2018 PAYMENT TOTALED \$24,272,137 ON 43,771,546 UNITS. GASLOG PARTNERS LP ESTIMATES THAT THEY WILL HAVE CURRENT OR ACCUMULATED EARNINGS FOR THE 2018 TAX YEAR WHICH WILL ONLY COVER A PORTION OF THE DISTRIBUTIONS FOR THE 2018 TAX YEAR. THEREFORE, A PORTION OF THE 08/10/2018 DISTRIBUTION SHOULD BE TREATED AS A NON-DIVIDEND DISTRIBUTION AND SHOULD REDUCE THE BASIS OF GASLOG PARTNERS LP. PLEASE SEE THE ATTACHED SCHEDULE FOR A BREAKOUT OF THE AMOUNT OF DISTRIBUTIONS THAT ARE ESTIMATED TO BE TREATED AS A DIVIDEND AND NON-DIVIDEND FOR EACH UNITHOLDER. GASLOG PARTNERS LP WILL CONTINUE TO UPDATE AND REFINE THIS ANALYSIS AND WILL PROVIDE UPDATES TO THE WEBSITE AS THEY ARE AVAILABLE.
