THE 02/11/2021 PAYMENT TOTALED \$475,178 ON 47,517,824 UNITS. GASLOG PARTNERS LP ESTIMATES THAT THE COMPANY WILL NOT HAVE CURRENT OR ACCUMULATED EARNINGS FOR THE 2021 TAX YEAR. THEREFORE, THE 02/11/2021 DISTRIBUTION SHOULD REDUCE THE BASIS OF THE OUTSTANDING GASLOG PARTNERS LP COMMON UNITS FOR THE 2021 TAX YEAR.**
