**14** Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ A CASH DISTRIBUTION WAS PAID TO HOLDERS OF GASLOG PARTNERS LP PREFERRED UNITS ON 06/15/2020. THE 06/15/2020 PAYMENT TOTALED \$7,582,109 ON 14,350,000 PREFERRED UNITS. GASLOG PARTNERS LP ESTIMATES THAT THE COMPANY WILL HAVE CURRENT OR ACCUMULATED EARNINGS FOR THE 2020 TAX WHICH WILL ONLY COVER A PORTION OF THE DISTRIBUTIONS FOR THE 2020 TAX YEAR. THEREFORE, A PORTION OF THE 06/15/2020 DISTRIBUTION SHOULD BE TREATED AS A NON-DIVIDEND DISTRIBUTION AND SHOULD REDUCE THE BASIS OF GASLOG PARTNERS LP. PLEASE SEE THE ATTACHED SCHEDULE FOR A BREAKOUT OF THE AMOUNT OF DISTRIBUTIONS THAT ARE TO BE TREATED AS A DIVIDEND AND NON-DIVIDEND FOR EACH UNITHOLDER. GASLOG PARTNERS LP WILL CONTINUE TO UPDATE AND REFINE THIS THIS ANALYSIS AND WILL PROVIDE UPDATES TO THE WEBSITE AS THEY ARE AVAILABLE.
