THE 06/15/2021 PAYMENT TOTALED \$7,582,109 ON 14,350,000 UNITS. GASLOG PARTNERS LP HAD CURRENT OR ACCUMULATED EARNINGS FOR THE 2021 TAX YEAR WHICH ONLY COVERS A PORTION OF THE DISTRIBUTIONS FOR THE 2021 TAX YEAR. THEREFORE, A PORTION OF THE 06/15/2021 DISTRIBUTION SHOULD BE TREATED AS A NON-DIVIDEND DISTRIBUTION AND SHOULD REDUCE THE BASIS OF THE OUTSTANDING GASLOG PARTNERS LP PREFERRED UNITS FOR THE 2021 TAX YEAR.
