14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ A CASH DISTRIBUTION WAS PAID TO HOLDERS OF GASLOG PARTNERS LP COMMON UNITS ON 05/13/2021. THE 05/13/2021 PAYMENT TOTALED \$475,268 ON 47,526,800 UNITS. GASLOG PARTNERS LP ESTIMATES THAT THE COMPANY WILL NOT HAVE CURRENT OR ACCUMULATED EARNINGS FOR THE 2021 TAX YEAR. THEREFORE, THE 05/13/2021 DISTRIBUTION SHOULD REDUCE THE BASIS OF THE OUSTANDING GASLOG PARTNERS LP COMMON UNITS FOR THE 2021 TAX YEAR.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ THE BASIS OF COMMON UNITS MUST BE REDUCED BY 100% OF THE TOTAL DISTRIBUTIONS RECEIVED DURING 2021. COMMON UNITHOLDERS WHO RECEIVED THE 05/13/2021 DISTRIBUTION MUST REDUCE THE BASIS IN THEIR UNITS BY \$0.01000 PER UNIT.

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶ THE 05/13/2021 DISTRIBUTION AMOUNT WAS \$0.010000 PER OUSTANDING GASLOG PARTNERS LP COMMON UNIT. THE ADJUSTED TAX BASIS OF EACH SHARE OF GASLOG PARTNERS LP COMMON UNITS IS THEREFORE TO BE REDUCED BY \$0.010000 SHOULD THE ABOVE REDUCTION EXCEED THE AMOUNT OF ADJUSTED BASIS, THE EXCESS IS TO BE TREATED AS A CAPITAL GAIN.
