14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ A CASH DISTRIBUTION WAS PAID TO HOLDERS OF GASLOG PARTNERS LP PREFERRED UNITS ON 09/15/2021. THE 09/15/2021 PAYMENT TOTALED \$7,411,736 ON 14,022,556 UNITS. GASLOG PARTNERS LP ESTIMATES THAT THE COMPANY WILL NOT HAVE CURRENT OR ACCUMULATED EARNINGS FOR THE 2021 TAX YEAR. THEREFORE, THE 09/15/2021 DISTRIBUTION SHOULD REDUCE THE BASIS OF THE OUTSTANDING GASLOG PARTNERS LP PREFERRED UNITS FOR THE 2021 TAX YEAR.
